- **Pay rates** - The payrates were submitted to the WACA on time, prior to the December 31<sup>st</sup> deadline. - **Memorandum of Understanding** - The MOU with the WACA is still a work in progress. The committee will record this as correspondence in and discuss at the next Committee Meeting in February.
- **Annual Season Dinner** - The dinner planning is now underway. We'll look to expand this potentially from the first one last season. The committee has nominated Ashlee (she's planning a wedding so a lot of this will be copy and paste work for her) and Jack (all round great bloke) to organise this event. More details coming soon at the next General Meeting.
- **Mid-Season Survey** - Those on our email distribution list would have seen an email to complete a mid-season survey. This is just a pulse check to see what the members feel is working well and not so well currently with the WACUA and the Committee. Thanks to everyone for the feedback. We're currently sitting well with a weighted average of 7.51 stars

I'll start off with an apology – there were several people at the last meeting that had both registered and paid for their membership where I'd missed marking them off. Sorry to those that were affected. We've gone through all the names again and hopefully we've fixed everything up.
