- Daniel read out report from Stephen Farrell:
 - Vacancies: President, Vice President, Secretary, Treasurer, Register (1 position each),
 Ordinary Committee Member (5 positions).
- At the closure of nominations, the following nominations were received.
 - President Trent Steenholdt nominated with John Sherry seconding. As there was only one nomination received, Trent Steenholdt is elected as President for 2019-2020.
 - Vice President Ahmad Khan nominated with Andrew Micenko seconding. As there
 was only one nomination received, Ahmad Khan is elected as Vice President for
 2019-2020.
 - Secretary Ashlee Gibbons nominated with Trent Steenholdt seconding. As there
 was only one nomination received, Ashlee Gibbons is elected as Secretary for 20192010.
 - Treasurer Andrew Micenko nominated with Trent Steenholdt seconding. As there
 was only one nomination received, Andrew Micenko is elected Treasurer for 20192020.
 - Register John Sherry nominated with Trent Steenholdt seconding. As there was only one nomination received, John Sherry is elected for 2019-2020.
 - Ordinary Committee Member Nominations received from: Ernest Chua (with Garth McCrorie seconding), Wayne Barron (with Todd Rann seconding), Todd Rann (with Wayne Barron seconding), Sean Ayres (with Ahmad Khan seconding), Paul Cassidy (with Trent Steenholdt seconding), Kirtsen Funston (with Trent Steenholdt seconding), Chaapa Pelpola (with Trent Steenholdt seconding), Darryl Sinclair (with Trent Steenholdt seconding), Mahesh Gopukuttan (with Trent Steenholdt seconding).
- Since receiving the nomination, Darryl Sinclair has decided to withdraw his nomination.
- Fred Davis said he put a nomination in however it was not received by the returning officer.
- Eight nominations have been received, only 5 available positions, so an election will be held.
- Nominees were given opportunity to speak.
 - Ernest Chua has got a lot from umpiring and wants to give back. Umpires at a lower lever so can bring diversity, is trained as a lawyer, is secretary of board gaming

- association so have previous experience. These are some reason why he would be an asset to the committee.
- No one else wished to speak.
- Election process was explained Preferential voting, need to number boxes 1-8 in order of most preferred. Must be a financial member to be able to vote. Come forward and get named ticked off, take ballot paper, complete and then put in box.
- Election was conducted.
- Result 3 informal votes. 5 people clearly elected on first preferences so no need to go to second preferences. Five elected people are: Kirsten Funsten, Sean Ayres, Ernes Chua, Wayne Barron, Todd Rann.
