Budget planning

General business:

- Merchandise for this season
 - Discussion of other types of merchandise we could investigate.
 - Alan Wilson mentioned that there are some brands or shops that we could recommend to members. E.g. sunglasses, shoes, hats. Action item: Alan Wilson to prepare a list of recommendations and circulate to the committee.
 - Black caps with the WACUA logo (we have no more navy caps)
 - Credit card Swiss army knives? Action item: Trent to investigate.
 - Notepad covers? Action item: Trent to investigate.
- MOU
 - Action item: Ahmad to email WACA Events for a quote/price indication of what the grand final breakfast may cost using Saturday morning prices. Also check what the cost of a Friday night buffet dinner for 60-70 people may cost.
 - Discussion around the clause in the MOU about the WACA subsidising a WACUA event at the WACA ground each season. Agreed to propose removing the dollar figure and leave the amount open to the WACA to decide.

- Co-branded merchandise? WACUA may lose control of a revenue stream.
 We'd be happy to maintain control (because of quality control/cost) and add WACA/WADCC logo.
 - WACUA would prefer to organise off-field gear in cooperation with the WACA
- Discussion around a clause putting responsibility for deciding on-field gear on the WACA. Registration fee could go towards this. Probably unnecessary as this is already determined by the WACA/WADCC.
- Action item: Trent, Martin and John to work on preparing the final revision in accordance with our proposed timeline
- Sponsorship renewal Mick Martell and Perth Metro Property Group.
 - o Focus more on leasing this season.
- First General Meeting October planning
 - BBQ Vijay Kumar (Andrew to confirm this with Vijay). Darryl Power as backup.
 - o Raffle Martin Brennan.
 - Attendance sheets printed by Trent with Nick Walters in charge of getting members to sign in.
 - Flyer/events calendar printout Lloyd Tifflin
- Match payment review
 - Approved in entirety! However, MyCricket admin for finals needs to be worked out. Also, 2 day finals are now a shorter duration due to a change to the playing conditions this season. Matthew Hall has emailed Trent Steenholdt (see correspondence in) to work out these points. Suggestion is to scale the finals to the new hours of play.
