On-field looking to move to single cover shirt, probably blue, for all comps, WACA sponsors on shirt, WACUA logo on sleeve, next season would get 2 shirts and jacket, future season get 1 shirt, new umpires 2 shirts and jacket. Possibly a renewal period with jackets. Looking to move to higher quality shirt as well. Possibly no sponsor on jacket so last longer. Off-field BLK online shop, off-field black and gold polo shirt, WACUA logo/sponsor on shirt, WACA logo on sleeve. Possibility to expand to other merchandise items. WACUA could buy top up amount.
- 14.1.1 amount not applicable due to support of annual dinner as part of registration fee – need to add support of annual dinner in the clause. WACUA to sell tickets to partners. Specifics to be worked out later. Discussion around the purpose on the night. Possibility of grand final medallions presented at annual dinner rather than at end of game. Clarity around the logistics/planning of the dinner.

 - 17 names that did not return from last season according to WACUA membership.
 - 30 people didn't come back from last season, a number who didn't umpire at all, others retired, other reasons given.
