MOU

- o John Sherry had meeting with Luke Douglas.
- Went through the clauses and decided which ones needed to be kept and which ones were unnecessary/covered by other things.
- Most significant change separated WACUA membership from the registration fee. New clause that WACA will facilitate collection of fees by members ticking a box.
- WACA responsible for on-field. WACUA for off0-field. Only condition is sponsors can't clash.
- o Every umpire will get two shirts this season as there is a new manufacturer.
- Likely that all umpires will wear same coloured shirt, regardless of grade. Eg no white shirt for first grade.
- Jackets will be black for everyone regardless of shirt colour. Will be heavily subsidised by WACA.
- Won't be able to wear any of the old gear (shirts/jackets etc) because of the complete change in manufacturer.
- Registration fee covers things like Seminar, possibly an umpire kit etc. Money to be used for the benefit of the umpires. WACA's responsibility to sell it to umpires.
- o Will still need to tick a box to become a WACUA member on the form.
- o If not a member, then possibly they have to pay full price for off-field shirt.
- Heath and Safety part taken out as it is covered by other polices.
- WACA membership it has been changed to fit with the WACA by laws.
 Process to change the by laws is too difficult. Case by case situations where people don't strictly meet the criteria will be decided by Luke Douglas.

- o Funding from WACA for event remains.
- John Sherry proposed that conditional acceptance be given, seconded by Trent Steenholdt. Carried.
