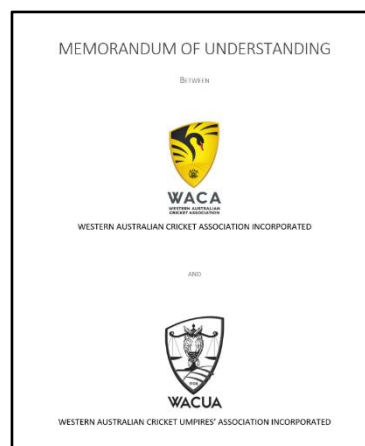
1. Memorandum of Understanding (MOU) Between WACUA and WACA

Treasurer's Report

We've seen a dip in our funds of \$1526.16 since the last general meeting. This is to be expected as membership payments from the WACA are yet to come in. The biggest cost has been merchandise, with the extra shirt order and more off field jackets costing \$2164.03. So please, if you have ordered a shirt or jacket please get your money in! It'll be a big help and will allow us to further refine our budget for the rest of the season.

Speaking of which...

With a little help from me, Trent has prepared a budget for this season, showing our expected costs and expected revenue. It's attached as an extra sheet in the financial spreadsheet. The current estimate is that by the end of the season, our balance will have improved by \$1242 over what we started the season with. This is an estimate only, and while our expenses are fairly well known, our revenue could be much more variable depending on whether all of the shirts and jackets that were ordered are paid for.

Our current balances are:

- \$1793.89 in the cheque account
- \$13 339.29 in the savings account
- \$60 in cash

Finally, on a non-treasury related note, on 6/11/2017 I attended the WADCC management committee meeting in place of Trent who was busy umpiring the Toyota Futures League match between WA and ACT/NSW Country. The topics of discussion were varied, but some points were particularly relevant to umpires. Here's a summary:

- Some clubs have noticed sledging creeping in during juniors games. They would prefer it didn't happen and if any umpires notice it, it would be great if they could act on it early.
- It causes frustration when umpires aren't completely familiar with the playing conditions, so even if you've read them through and completed the exams in MOS, now might be a good time for some revision!
- In junior games, as a courtesy, batsmen asking for drinks between overs should let the umpire and the opposing captain know. The drinks should be brought on by a player and not by a coach.
- In 3rd and 4th grade, any of the approved balls can be used, and clubs cannot demand that their opposition use a certain type of ball. If a ball needs to be replaced, any approved ball can be used (e.g. a Kookaburra ball can be replaced by an approved Dukes ball).
